- s. It is very unlikely that this project would be undertaken if not for financial assistance from the agency. However, if the project were to still occur without IDA assistance, it would look very different from its proposed program and would certainly not include a microbrewery or office space, elements that are beneficial to the Village and community.
- t. This project boast numerous elements that present positive impacts on the Village and falls very much in line with Port Chester's proposed zoning and redevelopment goals.

R&H Brewery will become a landmark restaurant and manufacturing space that will draw patrons from all across Westchester and beyond. With a stunning brick facade visible from the train and a location adjacent to the Capitol Theater, this impressive space will immediately become Port Chester's most desirable restaurant and event destination.

Floors 3 through 8 will consist of 36 housing units. These will be split between studios and one bedrooms, keeping the burden on the school system to a minimum. Three of the studios will be designated as affordable at 60% of Westchester County AMI.

Sitting above the residences on the 9th floor will be approximately 3,300 square feet of office space. Port Chester, given its designation as an opportunity zone, is uniquely positioned to attract growth companies to locate right here in town. Because we had to reduce our office square footage dramatically, this space will be primarily rented by our company, St Katherine Group, and a few local partners. We view this as a test case for Port Chester's viability as a business hub and believe this creative use mix and attractive location will be the first step in the Village's inevitable surge in the "work" aspect of "work, live, play."
